

VOLUNTEER AGREEMENT AND RELEASE OF LIABILITY

The Central Florida Dream Center (CFDC) deeply appreciates your willingness to serve as a volunteer. So that our volunteers will have a clear understanding of what it means to be a volunteer for the CFDC, we ask that you carefully read this Agreement and Release, and then if you agree with its terms, sign below.

YOUR ROLE AS A CENTRAL FLORIDA DREAM CENTER VOLUNTEER:

In consideration of being accepted as a volunteer of CFDC or in continuing as a volunteer, you agree as follows:

(1) You will not present yourself as a professional counselor, and will not provide or attempt to provide advice or guidance, whether medical, legal, psychological or other wise, during your volunteer service with CFDC, even if you have been licensed to do so by the state; (2) you are not an employee, agent, subcontractor, or independent contractor of CFDC and you have no expectation that, as a result of your volunteer service, you will be provided employment with CFDC, now or in the future. CFDC also will not provide you with compensation, unemployment insurance, worker's compensation, or any other benefit of employment in connection with your volunteer service; (3) You will seek to perform the volunteer duties assigned by CFDC to the best of your ability, and will comply with all policies and procedures of CFDC. (4) You or CFDC may discontinue your services as a volunteer at any time, with or without notice, and for any reason, with or without cause.

YOU RELEASE THE CENTRAL FLORIDA DREAM CENTER FROM LIABILITY:

As a volunteer of CFDC, you generally discharge and release CFDC, its officers, directors, employees and partnering agencies, from any and all claims, demands and liabilities for property damage, personal injury and/or death to you or your property, arising from your volunteer activities with CFDC. You consent to and release any form of media exposure including video and photographs of you while at our events to be used in print or video. You further covenant not to sue, or to commence any legal action, complaint, or charge against CFDC, its officers, directors, employees and partnering organizations regarding any matter covered by this agreement and release.

EMERGENCY HEALTHCARE AUTHORIZATION:

In the event of injury or illness, whether real or suspected, you authorize and give permission to take you or arrange for ambulance or other emergency transportation service to a doctor or hospital for medical diagnosis or treatment, including but not limited to emergency surgery or medication, and you assume the responsibility of all related fees and expenses arising there from.

If you are under 18, you also must obtain the consent, agreement and release of a parent or guardian who is legally responsible for you, as reflected below.
